- LUXURY:** The following vehicles are defined as Luxury Vehicles: Acura, Cadillac, Hummer, Infiniti, Lexus, Lincoln, Saab and Volvo.
- ULTRA LUXURY:** The following vehicles are defined as Ultra Luxury: Audi, BMW, Corvette, Jaguar, Land Rover, Mercedes-Benz, Mini, Porsche, and Viper.

RIGHT TO TRANSFER: The above registered vehicle owner shall have the right to transfer this Warranty to the next owner of the vehicle registered above without charge of any kind. Both the original and the first subsequent owner must complete, sign and submit a legible copy of the Transfer Request Form to PermaPlate within thirty (30) days from the date of purchase by such first subsequent owner. Tire & Wheel Protection Limited Warranty

ROAD HAZARD COVERAGE: This Warranty is between the Purchaser of the vehicle ("you") and PermaPlate Company, LLC ("we" or "us"). It provides for the repair or replacement of the vehicle's tires and wheels which, during the term of this Warranty, become Unserviceable due to any Road Hazard covered under this Limited Warranty. Unserviceable means that the tire has been punctured or otherwise damaged to the extent that it is unsafe, or that a wheel will no longer hold a seal with its tire or will hold a seal but the damage exceeds manufacturer tolerance guidelines. Tire and/or wheel damage that is cosmetic in nature and that does not render the tire and/or wheel Unserviceable is specifically excluded. A Road Hazard is a condition on a public roadway which should not exist on such public roadway, such as potholes, limbs, nails, glass, construction debris or other road debris. Eligible vehicles include current model year plus up to ten prior model years. **NOTE: YOU MUST OBTAIN AUTHORIZATION PRIOR TO REPAIR OR REPLACEMENT. SEE "CLAIMS PROCEDURES" FOR DETAILS.**

COVERAGE AND LIMITATIONS OF LIABILITY

VEHICLE EXCLUSIONS:

- a. Any vehicle with an MSRP over \$125,000 will not be eligible for the PermaPlate Tire and Wheel Protection Limited Warranty.
- b. The following Makes / Models are excluded from coverage under the PermaPlate Tire and Wheel Protection Limited Warranty: Aston Martin, Bentley, Ferrari, Ford GT, Lamborghini, Lotus, Maserati, Maybach and Rolls Royce.

TOWING AND ROADSIDE ASSISTANCE: We will dispatch a towing or roadside assistance vehicle during the Term of this Warranty by use of our toll free number (866-312-4696). Please provide the dispatcher with the vehicle identification number. We will dispatch prompt service to assist you in changing to your inflated/uninflated spare. Alternatively, in the event that the vehicle is not equipped with a spare tire, we will tow the vehicle to the closest available service station. Maximum towing benefit is \$100. If emergency service is required after hours, purchaser should contact a local road service company and we will reimburse your towing expenses up to \$100.

FLAT TIRES: You will be reimbursed for the reasonable costs you incur to repair a flat tire caused by a Road Hazard while operating the covered vehicle on public streets and in a legal manner.

TIRE REPLACEMENT: You will be reimbursed for the reasonable costs you incur to replace a tire, only if a tire covered by this Agreement becomes unrepairable due to damage caused by a Road Hazard. This coverage is valid through the tread life of the covered tire (3/32" or less is excluded) and replacement will be made with a tire of like kind and quality to such covered tire.

WHEELS (RIMS): You will be reimbursed for the repair or replacement of wheels rendered Unserviceable due to a Road Hazard covered under this Warranty. We reserve the right to have damaged wheels repaired at our cost by a qualified service provider of our choosing. We further reserve the right to replace the damaged wheel at our cost with a remanufactured wheel provided such remanufactured wheel is of like kind and quality to the wheel that was damaged by the covered Road Hazard. We will cover wheel replacement only in the event that the damaged wheel cannot be repaired.

MOUNTING AND BALANCING: You will be reimbursed for the reasonable costs that you incur for mounting, balancing, valve stems, and tire disposal for any tire replaced under this Agreement. However, unspecified charges for shop supplies are excluded.

TAXES: You also will be reimbursed for the cost of local and state taxes, as levied by state agencies for any tire or wheel replaced under this Warranty.

EMERGENCY TRAVEL EXPENSES (Subject to state law): In the event that your covered vehicle is disabled due to a covered Road Hazard, we will reimburse you for emergency living expenses for up to (3) days for costs that you incur for local lodging and meals. Maximum coverage is \$150.00 per day while your vehicle is being repaired provided that the disablement and repairs occur at least 250 miles from your primary residence.

CONDITIONS NOT COVERED: This Limited Warranty does not cover:

- a. Any damage that occurs outside the United States or Canada.
- b. Any damage resulting from off-road use, racing, collision with a curb, median, or another vehicle, chain damage, misuse, abuse, lack of proper maintenance, misalignment, suspension problems, use on a construction site or on roads not regularly maintained, vandalism or malicious mischief, theft, fire, or any loss covered by primary physical damage insurance.
- c. Any damage caused by driving on tires that are improperly inflated.
- d. Any damage to tires and/or wheels which are undersized, oversized, or otherwise not recommended by the vehicle manufacturer.
- e. Any damage to tires and/or wheels transferred from another vehicle subsequent to the effective date of this Agreement.
- f. Any damage to tires and/or wheels that are mounted on vehicles other than private passenger cars and light duty trucks (under 13,500 lbs. gross vehicle weight).
- g. Any damage which is covered by any other warranty, including warranties issued by the manufacturer.
- h. Replacement wherein the manufacturer, by public announcement of a recall, establishes its responsibility to replace tires or wheels.
- i. Any damage that is the result of a manufacturer's defect.
- j. Any consequential loss or damage whatsoever, including loss, damage, or injury to persons or property resulting from the failure of any of covered or replaced tire or wheel.
- k. Any loss where you or any person on your behalf falsely swears or commits any fraudulent act with respect to any claim.
- l. Any loss that is not reported to us within 60 days from the date the damage occurs.

WARRANTY HOLDER RESPONSIBILITIES: Proper tire care is necessary to obtain the maximum mileage and wear from a tire. It is YOUR obligation to ensure that your tire/wheel assemblies are kept in balance and alignment, and that your tires are operated at the proper inflation pressure. Tires should be checked monthly for proper pressure, signs of dry rot, and improper or excessive wear. Any such condition that cannot be corrected demands the replacement for the safety of the vehicle occupants.

CLAIM PROCEDURE: You must obtain authorization prior to replacement of any tire, and/or prior to any repair or replacement of any wheel. For authorization and instructions, please call PermaPlate Company, LLC at 800-453-8470 Monday through Friday from 8:00 a.m. to 6:00 p.m. MST. A claim form will be provided for you to complete and return to PermaPlate at P.O. Box 58, Salt Lake City, Utah 84110 within 30 days along with the following documentation:

- a. Front copy of this Warranty.
- b. Original replacement or repair invoice which must reflect:
 1. The tread depth of the damaged tire.
 2. Whether or not the damaged tire or wheel was repairable, and if not, why not.
 3. Whether or not the damage was due to a manufacturer's defect.
- c. Original receipts for Emergency Travel Expenses, if applicable.
- d. Any other information that we reasonably request.

In the event that tire and/or wheel damage occurs after our regular business hours, or on a weekend, you must obtain instruction and a claim form from our website at www.permaplate.com. Please note that all of our rights under this Warranty are hereby reserved. **Be sure to save all parts in case an inspection is requested.**

NOTE: WE RESERVE THE RIGHT TO INSPECT ANY DAMAGED TIRE AND/OR WHEEL PRIOR TO ITS REPAIR OR DISPOSAL. FAILURE TO PRESERVE DAMAGED PROPERTY MAY RESULT IN CLAIM DENIAL.

ARBITRATION: In the event you and we fail to agree to the amount of a covered loss, or whether coverage is provided under this Warranty, each party hereby agrees to submit the dispute to binding arbitration. In such an event, the parties shall share equally in the costs of such arbitration.

CANCELLATION: In the event that this Warranty is cancelled prior to its maturity, we shall refund the premium for this Warranty on a pro-rated basis, or by the refund method as may be required by your state, less \$25.00 cancellation fee (MT: No cancellation fee). If this Warranty is cancelled within the first thirty (30) days, no loss having occurred, the return premium will be 100% of the charge.
