## PRODUCT LIMITED WARRANTY

### 1. INTRODUCTION AND QUALIFICATIONS

- A. The Product is permanently applied on the Vehicle and therefore, this Product Limited Warranty is non-cancellable and the Product Purchase Price is non-refundable.
- B. New or used vehicles are eligible for this vehicle protection product.

### 2. KEY TERMS

- A. **“Administrator”** means Siskin Enterprises, Inc., the manufacturer of the Product.
- B. **“Product”** means the Theft Deterrent Vehicle Product installed on the Vehicle. The Security Code from the corresponding Product installed on Your Vehicle must be recorded on the Registration Page of this Product Limited Warranty.
- C. **“Obligor/Warrantor, We, Us, and Our”** means Siskin Enterprises Inc.
- D. **“Product Limited Warranty”** means this Limited Warranty that accompanies the Product You purchased.
- E. **“Purchaser,” “You” or “Your”** means the Purchaser shown on the front side of this Product Limited Warranty.
- F. **“Registration Page”** means the first page of this Product Limited Warranty.
- G. **“Security Code”** means the code installed from the Product onto Your Vehicle that is referenced on the front page of this Product Limited Warranty.
- H. **“Selling Store”** means the store from which Purchaser purchased the Product.
- I. **“Vehicle”** means the Vehicle shown on the front side of this Product Limited Warranty which is covered by this Product Limited Warranty.

### 3. GENERAL TERMS OF THIS PRODUCT LIMITED WARRANTY

- A. **Warranty Registration:** The Registration Page must be completed and submitted to Administrator within 30 days from the Product Purchase Date. Administrator assumes no liability for the failure of the dealer to submit this Limited Warranty on behalf of the Purchaser. Some states may not require the registration of this form in order to receive rights under this Warranty.
- B. Coverage under this Product Limited Warranty begins on the Product Purchase Date and expires at the end of the Product Limited Warranty Term listed on the Registration Page or:
  - 1. Upon a claim wherein the Vehicle has been stolen.
  - 2. You no longer own the Vehicle.
- C. There is no deductible associated with this Product Limited Warranty.
- D. This Product Limited Warranty is non-transferable and only applies to the original purchaser.
- E. This Product Limited Warranty does not cover loss occurring outside of the United States, Canada or Puerto Rico.
- F. Benefits under this Product Limited Warranty are in addition to Your settlement with your insurance carrier.

### 4. WHAT THIS PRODUCT LIMITED WARRANTY COVERS

This Product Limited Warranty guarantees that the Theft Deterrent Products will provide coverage as described below:

- A. **\$3,000 Cash Benefit:** If the Vehicle has the Product installed and is stolen and not recovered (by the police, the owner, or the insurance company) within thirty (30) days from its theft, We will pay You a \$3,000 cash payment, subject to the terms and conditions of this Product Limited Warranty.
- B. **\$2,000 Replacement Benefit Allowance:** In addition to the coverage in 4.A when a covered Vehicle is stolen and not recovered and You purchase a replacement vehicle of your choice from the original Selling Store, We will pay an additional \$2,000 towards the purchase price; payment to be paid directly to the Selling Store at time of purchase of the replacement vehicle.
- C. The Product is fully warranted against defects in materials or workmanship.

### 5. LIMITATIONS

- A. Vehicle must have the Product installed and in place at the time of theft to receive coverage under this Product Limited Warranty.
- B. This Product Limited Warranty is not applicable to third party beneficiaries, intended or otherwise.

## 6. EXCLUSIONS

- A. Vehicle theft if Purchaser has intentionally concealed a material fact or circumstance surrounding the disappearance of the Vehicle.
- B. Loss due to any fraudulent, dishonest, or illegal criminal act by You whether acting alone or in collusion with others.
- C. Loss resulting from Purchaser's failure to take reasonable precautions against theft (i.e., left keys in Vehicle or gave Vehicle to thief or otherwise left keys in thief's possession).
- D. Any loss occurring where the Vehicle is burned or is carjacked.
- E. Consequential damages arising from the disappearance or damage of the covered Vehicle.
- F. We shall not be responsible for any Loss arising out of the unauthorized access or use of any system, software, hardware, or firmware, or any modification, reprogramming, destruction, or deletion of data or software by any means.
