**Registration:** The registration copy of this Enrollment Form must be forwarded by the selling dealer to PermaPlate Company, LLC at P.O. Box 58, Salt Lake City, Utah 84110 within forty five (45) days of purchase of the vehicle. Failure to register or any alteration of this Enrollment Form voids the Warranty.

**Confirming your Enrollment:** If desired, you can confirm your enrollment with PermaPlate Company, LLC by telephoning (800) 453-8470 and asking for the Warranty Department.

**Instructions:** For instructions on transferring this Warranty, applying for benefits, and for applicable exclusions, see reverse side, or call the toll free number set forth below.

Benefits under this Warranty are payable if your vehicle is stolen and not recovered within thirty (30) days. The Alternate Benefit is payable if your vehicle is stolen and is recovered within thirty (30) days in a damaged, but repairable condition. You are not required to pay a deductible to receive service provided under this product warranty.

Benefits under this Warranty are in addition to your settlement with your insurance carrier.

**Warranty Period:** The Warranty period runs for 3 years or 5 years (as noted above) from the initial delivery date of the vehicle. This Enrollment Form is issued for the benefit of the named purchaser of the identified vehicle and for the first subsequent transferee of such vehicle.

## LIMITED WARRANTY (if enrolled)

**Benefits:** As the registered owner with the anti-theft product installed on the above named vehicle, you are entitled to the following benefit: Administrator/Warrantor is the manufacturer of the PermaPlate anti-theft product and hereby warrants that should the vehicle which has the anti-theft product installed be stolen and not recovered (by the police, the owner, or the insurance company) within thirty (30) days from its theft, we will pay you **\$2500.00** (US) cash payment. Subject to the terms and conditions of the product warranty.

**Alternate Benefit:** Up to \$1,000.00 "Deductible Reimbursement Allowance" if the vehicle is stolen and is recovered within the thirty (30) days. Such Deductible Reimbursement Allowance shall be equal to the amount deducted by your Comprehensive Insurance company in their settlement with you should your vehicle experience repairable damage.

**Insurer Information:** Obligations of the provider under this vehicle protection product Warranty are insured under a service contract reimbursement insurance policy. If a covered service is not provided by the Administrator/Warrantor before the 60th day after the date the consumer provides complete proof of loss, as required by Administrator/Warrantor the consumer may apply for reimbursement directly to the reimbursement insurance company. **Anti-Theft Warranty:** This agreement is a product warranty and is not insurance. It is not subject to state insurance laws but is subject to state law concerning warranties. To be eligible for this warranty, the warranty holder must have full comprehensive insurance coverage in effect on the date of theft. The benefit is payable as defined in the warranty, and subject to the satisfaction of the procedural proof and claim requirements of the warranty. The warranty holder shall be entitled to make a direct claim against the insurer covering the obligations of the warranty upon the failure of the warrantor to pay any covered claim within 60 days after a complete proof-of-loss has been filed with the party designated in the warranty. \*Note only the actual cash value of the vehicle as solely determined by the Administrator/Warrantor is paid if the insurance settlement is less than the payable benefit amount of this Warranty.

**Requirements and Required Verification:** To be eligible under this warranty, the warranty holder must have full comprehensive Insurance coverage in effect on the date of theft. It does not matter whether your vehicle was purchased by you as a new car or as a used car. In the event of a claim you must provide a copy of this original product application. All required and requested documents by Administrator/Warrantor must be received by certified mail (Return receipt requested within forty five (45) days of the date of theft). In order to make a claim, the required submittals include: a copy of police report filed within 48 hours of theft and evidence that the vehicle was insured with comprehensive coverage by a conventional insurance company and that your insurance company has paid the benefits required under your policy.

**Transfer and Renewal:** This Warranty may be transferred to another owner of the vehicle within the warranty period for the balance of such period upon payment of a \$25 transfer fee. The original or transferred owner may renew this Warranty annually after the initial warranty period by payment of a renewal fee of \$50. Transfer or renewal fee, together with a copy of this Enrollment Form, must be sent to PermaPlate Company, LLC at the address set forth below prior to the expiration of the applicable warranty period.

**Application for Warranty Benefits:** To apply for warranty benefits, submit a copy of this Enrollment Form, a copy of the police report, evidence that your insurance company paid the benefit due under your Comprehensive Insurance policy, to our warranty administrator: PermaPlate Company, LLC, P.O. **Exclusions and Definitions:** No warranty claims will be paid if the vehicle owner has intentionally concealed a material fact or circumstance surrounding the disappearance of the vehicle. 1. Theft guaranteed amount is strictly limited to amount shown on front of this form at the selected coverage plan. 2. Loss due to any fraudulent, dishonest, or illegal criminal act by you whether acting alone or in collusion with others is specifically excluded and will immediately void this warranty. 3. Any loss occurring outside of the USA, it's territories, or possessions. 4. When owner fails to take reasonable precautions against theft (i.e. left keys in vehicle or gave vehicle to thief or otherwise left keys in thief's possession). 5. Any loss occurring where the vehicle is burned or is carjacked. In no event shall PermaPlate Company LLC or its affiliates be liable for incidental or consequential damages arising from the disappearance or damage of the covered vehicle. Determination of fraudulent or dishonest acts shall be at the sole discretion of the sole Administrator/Warrantor. \*Note only the actual cash value is paid if the insurance settlement is less than the stated value of this warranty.

**Completeness of Application:** This Enrollment Form contains the entire understanding between PermaPlate Company, LLC and the applicant with respect to the Etchguard product and its accompanying Warranty. There are no representations, warranties, agreements, or arrangements (oral or written) relating to this Form which are not fully expressed herein.

**Cancelability of Warranty:** Anti-Theft devices are permanently installed on the covered vehicle and these warranties are cancelable and/or refundable. This contract may be cancelled by YOU within the first 30 days and the contract holder will receive a full refund. Cancellation can also occur for nonpayment by the consumer for the vehicle protection product, a material misrepresentation by the consumer to the seller or warrantor, fraud by the consumer, or a substantial breach of duties by the consumer relating to the warranty. **If the Warrantor cancels this warranty, the Warrantor shall mail a written notice of cancellation to You at the last known address in Our records at least thirty days prior to the effective date. The notice shall state the effective date of cancellation and the reason for cancellation.** You may cancel this Contract by surrendering your copy of this Contract with written notice to the Administrator, and if you have not filed a claim against the Contract. In the event this Contract is cancelled by You, we will keep a prorated amount of the Contract Price based on the greater of days in force compared to the total time of Your Contract Term, plus a cancellation fee, if applicable. Cancellation fee is \$25. In the event of cancellation, Administrator authorizes the lien holder to receive any refund amount. Cancellation may be requested by a lien holder in the event of a repossession. The refund amount will be calculated in accordance with the provisions stated in this Contract. **Administrator shall not be liable for damages because of use, misuse, or loss of business or profits or any other type of consequential or incidental damages.** The purchase of the product is optional and is not required to obtain financing.

**Arbitration:** In the event you, the agreement holder and the Administrator/Warrantor fail to agree whether coverage is provided under this warranty, each party shall agree to submit the problem to impartial arbitration. In such event, the parties agree to abide by the finding and will share equally in the cost of arbitration.
