5 YEAR LIMITED WARRANTY

RENEWABLE FOR LIFETIME COVERAGE

WARRANTY: Siskin Enterprises, Inc. ("Siskin") hereby guarantees to the vehicle owner that those portions of the vehicle treated with Perma-Plate Paintguard®, Fiberguard® and Leatherguard® will not sustain damage as described below. This guarantee is effective for five (5) full years from the date of purchase except where otherwise noted and is subject to all terms and conditions of warranty as set forth in this document.

PERMA-PLATE PAINTGUARD®: Siskin guarantees that the exterior painted surface(s) of the vehicle treated with Perma-Plate Paintguard will retain their high luster and shine as of the date of purchase. Should the original painted finish be damaged by weather induced fading, oxidation or loss of gloss, Siskin will repair such condition completely free of charge. Siskin reserves the right to attempt to repair any such damage through surface reconditioning (professional detailing) prior to repainting any surface. Damage resulting from water spotting, bird droppings, tree sap, acid rain or industrial fallout is limited to the cost of surface reconditioning.

PERMA-PLATE FIBERGUARD®: Siskin guarantees that the interior fabric upholstery, carpet and fabric door panel inserts of the vehicle treated with Perma-Plate Fiberguard will remain free of permanent stains from the date of application. Should permanent staining occur to the interior fabric of the vehicle, the stained area will be replaced completely free of charge. Siskin reserves the right to attempt to remove any stain through professional cleaning prior to replacing any surface.

PERMA-PLATE LEATHERGUARD®: Siskin guarantees that the vehicle's interior leather and vinyl treated with Perma-Plate Leatherguard will not be damaged by certain environmental conditions. Should any treated area be damaged by the sun or temperature extremes causing fading, discoloration or cracking, Siskin will repair such condition completely free of charge. Siskin reserves the right to attempt to correct any such damage through professional reconditioning prior to replacing any surface.

ELIGIBILITY: Vehicles of the current model year which are new, previously untitled and with less than 7,500 miles on the odometer at the time of purchase are eligible for five (5) year new car coverage. Such new car coverage will be extended to Factory Program vehicles and Demonstrator vehicles of the current model year with less than 20,000 miles on the odometer at the time of application for five (5) full years from the in-service date (date of first use) or until the vehicle is five (5) years old. A Factory Program vehicle is one that has previously been titled to a Car Rental Company prior to ownership by the first private party. Vehicles of the previous model year which otherwise meet the above criteria will be accepted for new car coverage if owner's purchase date is prior to July 1st. Previously owned vehicles or vehicles outside of the above terms will be covered for a period of five (5) full years from the date of purchase, but warranty coverage is limited to the cost of professional cleaning and/or surface reconditioning and reapplication of the applicable Perma-Plate product(s). R.V.s and Conversion Vans are not eligible for this warranty.

RIGHT TO RENEW: At the end of the warranty term, the original vehicle owner may elect to renew warranty coverage (as a previously owned vehicle in all cases) by having the Perma-Plate products professionally reapplied to the vehicle within thirty (30) days of expiration of warranty coverage. Another warranty must be issued from an authorized Perma-Plate dealer and the registration form must be forwarded to Siskin to activate the extended warranty.

VEHICLE OWNER REQUIREMENTS: Vehicle owner should maintain the vehicle by regular washing of the exterior and frequent vacuuming of the interior carpet and upholstery. Siskin strongly recommends use of the Perma-Plate Maintenance Kit and following the maintenance procedures for interior and exterior care as described in the Care and Maintenance Tips section at www.permaplate.com. SISKIN IS NOT OBLIGATED OR RESPONSIBLE FOR GENERAL CLEANING AND MAINTENANCE OF THE VEHICLE'S PAINT, FABRIC OR LEATHER SURFACES. REGULAR CLEANING AND CARE IS NECESSARY.

LIMITATIONS OF COVERAGE: This warranty does not cover damage existing prior to the application of Perma-Plate products or damage to surfaces not treatable with Perma-Plate products (non-glossy paints, headliners, seat belts, steering wheels, or other materials as determined by the design of the vehicle); or damage caused by road hazards, vandalism, collision, fire or other natural casualties; or damage resulting from manufacturer defects, rusting of metal, modifications or alterations of the factory's original finish; or additions made to the vehicle after leaving the factory; or damage caused by abuse. This warranty further excludes damage to painted surfaces caused by chips, scratches or defective paint (such as peeling or chipping of paint or factory clear coat; or paint separating, cracking or flaking; or other defects as determined by independent inspection or factory bulletins). Also excluded from coverage is damage to interior fabric, leather or vinyl caused by dye, ink, tar, gum or paint; bleach, acid or other caustic or corrosive substances; burns, rips, tears, or other similar damage; surface wear and tear or natural creases in leather and vinyl seats; or damage caused by poor adhesion to the surface to which leather or vinyl has been attached.

REPAIR OBLIGATIONS: Siskin has sole discretion in determining and implementing repair procedures. Such service will be performed with reasonable promptness and quality. Siskin's obligation shall be limited to one allowable repair per affected area. Siskin has no obligation for reimbursement of transportation or inconvenience costs during time of repair. Siskin's liability is limited to the lesser of the cost of repair or the trade-in value of the vehicle. If warranty covered damage has occurred, Siskin will pay only for the repair of the damaged portion of the vehicle.

CLAIM PROCEDURE: To be valid, a claim must be filed during the warranty period and may only be paid on a properly registered and/or transferred warranty. In order to reasonably minimize further damage which might occur, a claim also must be filed within sixty (60) days from the onset of damage by notifying Siskin at its telephone number or address listed below. A COPY OF BOTH SIDES OF THIS WARRANTY CERTIFICATE MUST BE FORWARDED TO SISKIN WITHIN SIXTY (60) DAYS FROM THE EARLIER OF EITHER THE APPEARANCE OF DAMAGE COVERED BY THIS WARRANTY, OR THE TIME WHEN THE DAMAGE COULD HAVE BEEN DISCOVERED UPON REASONABLE OBSERVATION OR INSPECTION. FAILURE TO FORWARD A COPY OF THE WARRANTY WITHIN SIXTY (60) DAYS OR FAILURE TO DILIGENTLY PURSUE A CLAIM WITHIN SIXTY (60) DAYS OF FILING, VOIDS THIS WARRANTY PERTAINING TO SUCH DAMAGE. ANY REPAIR UNDERTAKEN WITHOUT EXPRESS, WRITTEN AUTHORIZATION FROM SISKIN WILL NOT BE REIMBURSED.

TERMS AND CONDITIONS OF THIS WARRANTY ARE AS STATED ABOVE AND CANNOT BE ALTERED UNLESS DONE SO IN WRITING BY SISKIN. This warranty specifically excludes Siskin from liability for incidental or consequential damages caused by use of Perma-Plate products. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exception may not apply to you. No express rights are given under this warranty except for those specifically described herein. This warranty gives you specific legal rights and you may also have other rights which vary from state to state.
