## Windshield Protection Limited Warranty

**COVERAGE AND CONDITIONS:** PermaPlate Company, LLC ("PermaPlate") will provide for the repair of chips or cracks caused by small rocks, stones or other propelled road debris to the windshield of the owner's Recreational Vehicle. In the event that any covered windshield damage cannot be repaired (which will be determined by an authorized technician or PermaPlate), PermaPlate will allow for the replacement of the damaged windshield. Coverage is applicable only when such loss occurs during the term selected on the reverse and is subject to all terms and conditions set forth below.

**LIMITATIONS:** PermaPlate Windshield Protection may ONLY be purchased at the time of vehicle sale by an authorized dealer. PermaPlate will not cover: Pre-existing damage (damage prior to the effective date of this Warranty); cracks or other damages caused by any peril other than the impact of small rocks or flying road debris. Examples of excluded items include, without limitation: stress cracks; collision or similar accident; pitting or other damage caused by inclement weather conditions (i.e. lightning, earthquake, hailstorm, sandstorm, etc.); factory defects; damage due to theft, vandalism, acts of war or terrorism; damage that occurs while vehicle is being driven off of a paved street or highway; or windshield replacement necessitated by the failure of the vehicle owner to take reasonable steps to mitigate damages, including but not limited to the failure to report damage in a timely manner per the Claim Procedure below.

**REPAIR OBLIGATIONS:** If covered damage has occurred, PermaPlate will pay for the lesser of: The balance remaining of the aggregate total; the repair; or, if necessary, the removal and replacement of the windshield with OEM or like kind and quality glass. PermaPlate has sole discretion in determining and implementing repair procedures. Such repairs will be performed with reasonable promptness and with quality workmanship. PermaPlate will not reimburse customers for services rendered by any other repair facility unless prior written authorization is given. PermaPlate has no obligation for reimbursement of transportation or inconvenience costs during the period of repair.

**CLAIM PROCEDURE:** To be valid, a claim must be filed during the Warranty period and may only be filed by the registered vehicle owner or, if applicable, the properly transferred vehicle owner. In order to reasonably minimize further damage which might occur, a claim also must be filed within fourteen (14) days from the earlier of either the appearance of damage covered by this warranty or the time when damage could have been discovered upon reasonable observation or inspection by contacting PermaPlate at its telephone number or address listed below. PermaPlate will take the information necessary to process the claim and will assign the repair to an authorized technician. **FAILURE OF THE VEHICLE OWNER TO DILIGENTLY PURSUE A CLAIM WITHIN FOURTEEN (14) DAYS FROM THE ONSET OF DAMAGE VOIDS THIS WARRANTY PERTAINING TO SUCH DAMAGE. ANY REPAIR UNDERTAKEN WITHOUT EXPRESS, WRITTEN AUTHORIZATION FROM PERMAPLATE WILL NOT BE REIMBURSED.**
